Do you have July 12-16, 2017 inked – not penciled! – on your calendars? If not, mark those dates for The Ninety-Nines International Conference, hosted in San Antonio by us, the South Central Section.

The Conference website is open – SCS members should be among the first to register for the Conference and reserve hotel rooms! The Conference hotel is the Westin Riverwalk, a beautiful property located on a relatively quiet stretch of the river, but within easy walking distance to all of the Riverwalk attractions. Because the South Central Section is hosting the 2017 International Conference in July, the spring Section Meeting will be hosted by the SCS Board in a condensed format. The Board meeting and Business Meeting will take place on **Saturday**, **May 6**, at the Westin Riverwalk Hotel in San Antonio, during the morning. The afternoon will be dedicated to Conference planning and Conference Committee reports, which are expected to wrap up by 5:00. Attendees are encouraged to stay Saturday night as well to enjoy the San Antonio Riverwalk.

Hotel reservations for the Section Meeting must be made through Travel Planners, Inc. (TPI) using the Hotel Reservation Form to obtain the preferred rate. **Do not call the hotel directly.** The group rates are available Friday, May 5, and Saturday, May 6. **Reservations must be made by March 31 to obtain the group rate.**

The meeting registration fee is \$25 to cover the cost of the meeting room on Saturday. Meals are "on your own." There is no registration fee for guests.

For those arriving Friday, a group dinner has been set up at Rita's on the River, which is a short walk from the hotel. The price of \$25 includes fajitas, beans, rice, fajita accompaniments, iced tea or soft drink, tax, and gratuity.

LEGISLATION REPORT

Third Class Medical Reform.

Much has happened since Third Class Medical Reform was passed in 2016. Although President Trump signed an executive order suspending pending regulation, AOPA has determined that "BasicMed" will not be affected.

"BasicMed" goes into effect May 1, 2017. You qualify for "BasicMed" if you have held a medical certificate or special issuance - without suspension, revocation or withdrawal – on, or any time after, July 15, 2006.

To fly under "BasicMed", you will need to obtain a physical exam from a state-licensed physician. The exam must follow a checklist (currently being determined by the FAA) that is completed by both the pilot and the doctor. You must also complete an online course.

The ladies attending GIFT week worked on their private pilot license, commercial, instrument or CFI. The cost of airplanes were as low as \$30 per hour, plus fuel, with no charge for CFI or ground school.

Mary Latimer, Founder of GIFT and Chair of 99s Wichita Chapter has been a flight instructor since 1974 and is a designated pilot examiner (private, commercial, and instrument). She is a corporate pilot flying a Conquest II and an A&P mechanic with Inspection Authorization. She is also a retired air traffic controller after twenty-four years of service. She is considered one of the best ground school instructors in Wichita Falls.

GIFT week would not be possible if not for Mary, her family, several CFI volunteers and other volunteers who all worked to gmake this week to happen in 2016. It is planned as an annual event.

Brenda Sanchez, Houston 99, received her PPL and instrument 12 years ago. After 8 years of not flying, she began taking lessons and learned of the GIFT program. Brenda signed up for the program, traveled to Vernon, and on October 14, 2016, Brenda earned her Commercial Pilot 'sLicense.

"This was an amazing experience", stated Brenda, "not only for me, but for all ladies attending!"

The SCS AE Scholarship Committee has completed its review of 2017 applications We had a challenging year and I'd like to share some insights from common mistakes and issues that we worked through, not just this year, but most years. Hopefully this information will help your future applications and help your chapter representatives help you!

Disclaimer! The information presented below is up to date at the time of this writing for the 2017 AE applications. Scholarship requirements and forms are updated or changed annually. It is up to the applicant to verify information at the time of her application.

Below are the differences between the AE scholarship specifically and some of the scholarships administered through the AE Trust. AE scholarships are broken down into Academic, Flight Training and Type Rating requests. The basics for all of the scholarship requests the AE trust administers are noted below. Note: In all cases, please refer to the 99s website and specific instructions for each scholarship category!
